



SAFRE Amazon Gift Card Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.

Eligibility. Amazon Gift Card Giveaway (“Giveaway”) is only open to legal residents of the United States residing in the state of North Carolina and who are 18 years of age or older at the date of Giveaway entry. Employees of Civic Federal Credit Union, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of employees are not eligible to participate in the Giveaway. This Giveaway is subject to all applicable federal, state, and local laws and regulations. Void where prohibited. The Sponsor retains the sole discretion to determine any issue of eligibility and its decision will be final.

Sponsor: The Sponsor (“Sponsor” or “Civic Federal Credit Union”) of the Giveaway is Civic Federal Credit Union, 3600 Wake Forest Road, Raleigh, NC 27609.

Giveaway Period. The Giveaway will begin on August 11, 2021 at 8 a.m. Eastern Time (“ET”) and end on August 20, 2021 at 5 p.m. ET (the “Giveaway Period”). All times are listed in Eastern Time Zone, whether Eastern Daylight Time (EDT) or Eastern Standard Time (EST).

How to Enter. You may enter the Giveaway by submitting an entry in accordance with the instructions posted on the sign advertising the Giveaway at the South Atlantic Fire Rescue Expo (“SAFRE”). The entry must fulfill all Giveaway requirements, as specified on the SAFRE sign, to be eligible to win. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor. Alternatively, you may submit an entry by mailing a 3”x5” card that includes your name, address, telephone number and email address to the following address: Civic FCU SAFRE Giveaway, 3600 Wake Forest Road, Raleigh, NC 27609. Mail-in entries must be postmarked by August 20, 2021 and received by August 27, 2021. Regardless of entry method, a maximum number of one (1) entry may be received by any one individual over the course of the Giveaway Period. Additional entries received in excess of the maximum number of entries will be void. The Sponsor assumes no responsibility for incorrect, invalid, terminated, or non-functioning social media accounts or lost, incomplete, late, illegible, or undelivered entries. Entries not complying with these Official Rules are subject to disqualification, at the Sponsor’s sole discretion.

Prize. The prize is one (1) \$100 Amazon Gift Card (the “Prize”). The prize is nontransferable to any other person or entity. No cash redemption or substitution of the Prize will be made, except by the Sponsor in its sole discretion due to causes determined solely by the Sponsor, and then for a prize of equal or greater value. Any and all Prize-related expenses, if applicable, including without limitation, any and all federal, state, and/or local taxes, shall be the sole responsibility of the winner. Winner will be required to provide information, verbally or in writing, to show proof of eligibility in compliance with the specific Giveaway.

Odds. The odds of winning depend on the number of eligible entries received during the Giveaway Period.

Winner Selection and Notification. One (1) potential Prize winner from Facebook will be selected by a random drawing to receive the Prize (“Winner”) on or about August 27, 2021. You need not be present at the time of the drawing to be eligible to win. The Winner will be notified through Facebook direct message, email or telephone within five (5) business days following the drawing. The Winner will be required to respond to the Sponsor within three (3) days following notification as a condition of receiving the Prize.

The Sponsor shall have no liability for Winner’s failure to receive notices due to spam, junk email or other security settings, or for Winner’s provision of incorrect or otherwise non-functioning contact information. Sponsor’s inability to contact the Winner within a reasonable time period, the Winner’s failure to respond or

provide additional information in accordance with these Official Rules, or otherwise accept the Prize, will result in the Winner's disqualification and, at Sponsor's discretion, an alternate Winner may be selected.

Receipt by the Winner of the prize offered in the specific Giveaway is conditioned upon compliance with any and all federal, state, and local laws and regulations. Any violation of these official rules by Winner, at Sponsor's sole discretion, will result in Winner's disqualification, and all privileges as Winner will be immediately terminated.

By entering the Giveaway, you understand and agree that Sponsor, anyone acting on behalf of Sponsor, and Sponsor's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Giveaway, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purpose, without any further compensation, notice, review, or consent.

Terms and Conditions. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Giveaway in the event the administration, security, fairness, integrity, or proper conduct of the Giveaway is jeopardized or in the event the Giveaway is unable to run as planned for any other reason.

Any attempt by an entrant to deliberately damage any website or undermine the legitimate operations of the Giveaway may be a violation of criminal and civil laws. Should such attempt be made, Sponsor reserves the right to disqualify an entrant and to seek damages to the fullest extent permitted by law.

Sponsor's failure to enforce any provision in these Official Rules shall not constitute a waiver of that provision.

Limitation of Liability. By entering, you agree to release and hold harmless Sponsor and its subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, damage or expense (including attorneys' fees) that may occur, directly or indirectly, whether caused by negligence or not, from: (i) your participation in the Giveaway and/or your acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or internet service; (iv) unauthorized human intervention in any part of the entry process of the Giveaway; (v) electronic or human error in the administration of the Giveaway, the announcement of the Winner, or the processing of entries. Sponsor is not responsible for any typographical or other error in the printing of the Giveaway offer, administration of the Giveaway, or the announcement of the prize.
